1. Welcome

Apologies from Ben Freeman, Freshford Nurseries; Kim Syrus, HMA; Marlene Weise, community representative and Andrew Carrick, Botanic Gardens of SA were noted.

2. Business arising from last meeting

2.1 Arborist Conference 2018

Glenn Williams thanked ATS and SAPN for funding his attendance at the Conference and gave an overview of some of the key presentations and learnings. A few key points were:

- Growth regulator trials commercialising the product in Australia, lots of questions not answered, jury still out long term
- LiDAR limitations
- Panel session on efficiencies of reviewing span based audits (vs lump sum models) over servicing on rural properties and biosecurity

3. Regulatory Reset Proposal 2020-25

Jess Vonthethoff provided an update on the progress on the 2020-25 Reset Customer Engagement Program. SAPN considering how do business more efficiently to reduce/ manage our costs.

Kelvin provided a few thoughts on the deep dives sessions. In summary:

- Process was thorough and interactive vs previous engagement.
- Gaps were identified in CAPEX and OPEX and further information was provided.
- No extra cash political/ social market.
- SAPN still bear brunt of higher process due to ignorance in the market.

The Draft Plan will be launched on Wed 8 August. ARG members to be invited.

4. Visual amenity assessment

A number of possible sites have been identified, including:

- East Ave, Beverly Jacaranda's
- Woodside Rd, Lobethal Ash trees
- Main St, Mount Torrens Plum trees
- Main Rd, Blackwood Grey box species
- Main St, McLaren Flat mix of Ash, crab apples and eucalyptus trees
- Commercial Rd, Seaford Tuckeroo trees
- Savas Rd, Rostrevor Chinese Pistachio
- Port Augusta eucalyptus/ natives

The next step is to set up a meeting with ATS to discuss trialling different cutting techniques to determine the impact on the tree in terms of visual amenity and health/ structure.

5. Species selection

Feedback form the workshops was positive and there is overwhelming support for the development of a list to provide guidance to Council and community on species suitable under powerlines.

Seed are now working on refining the list for final review and feedback. The 'how" is crucial in terms of regulation, engagement with the nursery industry and Councils/ community.

6. Protocol review

The protocol is being reviewed in 2018. A survey was sent out to all Councils seeking feedback on

- What's working?
- What are the opportunities for improvement?
- What are the areas for greater collaboration?

In summary:

- 45% felt our performance improving
- What working well?
 - Communication early and ongoing
 - Opportunities for partnerships eg. tree removals/ replacement
 - Notification of program
 - Managing the risk
- Opportunities for improvement?
 - Visual amenity and shaping
 - Engagement with community and Council officers eg. depot staff
 - Site specific and species-specific vegetation management
 - Changing legislation to improve outcomes
 - Species selection
 - Education and awareness
 - Weed removal

7. Update on strategic initiatives

7.1 Regulatory amendments

A Discussion Paper has been developed to outline the proposed amendments, including the rationale for seeking a change. Consultation will be sought over 8 weeks. The paper will be distributed as follows:

- A letter to every CEO 68 Councils
- A letter to every Mayor 68 Councils
- An email (refer below) to the vegetation contact person from each Council
- A letter to the CEO of key government agencies DPTI, DEW, CFS, MFS
- An email to government agency contacts DPTI, NRM Boards, SA Water, CFS, MFS, DEW, NVC, ElectraNet, PIRSA
- An email to all CEOs of the Regional Council Groups
- Our consultative groups Arborist Reference Group and LG Working Group

Stakeholder workshops will be held in September/ October 2018.

The Principles of Vegetation Clearance Regulations expire on 1 September 2021.

7.2 Visibility tool – user experience

SAPN are currently working on the development of a visibility tool (proof of concept) for vegetation management to enhance customer and council engagement. The draft tool was shown to the group and feedback was positive that it was heading in the right direction.

7.3 Sapling trial

Sapling removal is now allowed under the *Native Vegetation Act* for saplings under 5 years of age (without an offset being required).

SA Power Networks in partnership with the Adelaide Hills Council is undertaking a sapling removal trial in the Gumeracha area during June and July 2018. The trial will involve the removal of saplings in 69 spans in the Gumeracha Weir, Chain of Ponds and Forreston area. The removals will be undertaken on both public roadsides and on public/private land

7.4 Training program for contractors

In 2018, contractor training will focus on hazard tree and sapling identification and native vegetation.

The draft hazard tree/ sapling identification presentation has been prepared.
